This then is the annual report our constitution requires I give.

Let me begin by saying the state of the ACA is good. Financially we have the resources to conduct the operations of the ACA. For our members the attachments will give you the complete picture of our beginning balance for this year and the estimate of funds we will have remaining after our activities this year for next year's operations.

As an association we have made considerable progress since our last report. Among the major accomplishments was the revision and approval of our Constitution. While revising the document was at times acrimonious we have, in fact, refined the guidance we have to work with to run the organization. And, some of the worst fears we had in revising the document have not come to pass. Reviewing our Constitution is something we should do every couple of years to ensure two things: that the Constitution's provisions guide the ACA to where we want to go, and that we comply with those provisions. That last statement, "that we comply with those provisions" has taken on greater meaning in light of the fact of our incorporation in the State of Florida and our anticipated filing of tax exempt status. Many of the provisions in our Constitution were written to assure we comply with the laws to maintain the status we have worked to achieve.

Last year Tom Zima began the process of surveying the location of our next Reunion. As a result of his efforts the Board selected Fort Walton Beach as the location of our 2008 Reunion. You can find more details about this in our Shell and Flame Newsletter and on our web site. Planning is almost complete for this event and our brothers of the Emerald Coast Chapter have been making preparations for the get-together. This effort once again honors one of the primary reasons for our existence as an organization, camaraderie, a chance for all of us to get together, share war stories and have a good time. Thanks to the many who make this possible and especially our brothers of the ACA Emerald Coast Chapter.

One aspect of our organization that has continued to challenge us on the Board is maintaining our membership. And actually, what we would really like to do is increase our membership. At present we have 117 Chief members, 9 Associate members and 6 Honorary members. The ACA's peak membership was 143! However, there has been a steady decline with many individuals paying dues for one year and then being dropped from the active roll for non-payment. We hate to lose you as it is only through active participation of the membership that we can achieve the ACA's objectives, first of which is camaraderie, but also include many efforts to support the AMMO community. Once again approximately 10% of those who paid dues in 2007 have not yet renewed their membership for 2008. Why this continues to happen is a mystery to the Board of Directors, perhaps it is something we did or didn't do. To those whose memberships have lapsed, we hope you will come home and renew your membership.

The ACA Board of Directors hashed out this year's budget. Among the key things we set out to do was to continue our support of the Gauvin Memorial Scholarship Fund. This year was the 10th Anniversary of the

fund and in February Jim Kerchinski represented the ACA in making our annual contribution at a memorial gathering in Hawaii to commemorate the occasion. We've taken care of the mundane things such as tax filing, refiling our incorporation papers in Florida and are on the cusp of gaining tax-exempt status. We continue to support the AMMO School House and AFCOMAC with recognition for outstanding performers. The ACA Board approved the expenditure of \$600.00 for charitable causes yet to be determined. This will come mainly around the holidays and on an as needed basis. We've authorized \$200.00 for our Sunshine Committee to do the work that committee does to acknowledge the loss of AMMO troops and those we love and to provide a kind word and show our concern when tragic health issues arise. More details are in the budget provided to each member.

We have gotten a little more organized in our presentations and in the process found a way to save a bit of money without significantly detracting from the quality we've traditionally put forth in our chapter charters, Shell and Flame Award, and individual recognitions. A great deal of thanks for these advances go to Mark Gossett, Mike Curran, and Joe Dominguez who worked on the committee to revamp these items. Mike Curran and Fred O'Hern have been busy as well working up plans to revamp our Trinket Shop. Many of the items in the Shop have been there for a number of years so we are holding a fire sale to move some of this older merchandise and we are going to restock the store with fresh offerings. Fred and Mike are also working on a purchase order for some new ACA coins. More information about the sale will be in our Shell and Flame Newsletter and on our web site.

We have several endeavors ahead of us yet. The Board is obligated to review our Strategic Plan and bring it up to date as best we can. We have an election we will hold later this summer and fall and for once we will be electing just those who actually are due for election as scheduled. No slots to be filled due to early resignations. And of course, we have our Reunion to attend and our General Membership meeting to be held while there.

As an organization, the ACA is starting to mature and develop into one that has the foundation to endure for many years to come. That foundation is the result of the efforts of all of the leaders of this Association who have come before. Each has left something of themselves that make this an Association of which we can be proud. The state of the AMMO Chiefs Association is much more than what these few paragraphs will ever capture. At its very foundation though is our membership and the fact that we are AMMO and proud of it.

Lastly, I would like to thank the members of the ACA Board of Directors,

both this year's Board and last year's, for dedicating their time and diligence to guiding the AMMO Chiefs Association. Beginning with January of 2007 all of our meetings, debates, creations of agenda, and resolution of strongly held (read that as stubbornly held) views on the part of many of us have been resolved either through emails or occasional on-line meetings which never lived up to being equal to sitting in the same room together to hash things out. Despite the drawbacks of not being able to meet face-to-face we managed to get the Association's business done.

On the balance, it has been another good year for the AMMO Chiefs Association. Look forward to seeing all of you in Fort Walton Beach.

Situated very close to the hotel is the National Museum of the United States Air Force, the world's largest and oldest military aviation museum, hosting more than one million visitors annually. The museum's galleries present military aviation history, boasting more than 400 aerospace vehicles – many rare and one-of-a-kind – along with thousands of historical items and powerful sensory exhibits that bring history to life and connect the Wright brothers' legacy with today's stealth and precision technology. The museum is open 9 am to 5 pm seven days a week. Admission is free, but there is a charge for the IMAX theatre. Self-guided tours require about two whole days to see most of the exhibits. Therefore, if you wish to tour the museum, you are strongly urged to spend two or three days in Dayton either before or after the reunion. 
